



## REGIONAL ECONOMIC IMPACT – CAPITAL

Private nonprofit colleges and universities have a significant presence in every region of New York State. In the Capital region, 15 independent colleges and universities enroll 40,000 students and award 10,000 degrees annually.<sup>1</sup>

## JOBS

The Independent Sector supported 11,000 direct campus jobs throughout the Capital region in fiscal year 2022-23, including faculty, staff, and graduate assistant positions. In total, after accounting for on-campus construction and spillover employment, the Independent Sector supported 21,000 total jobs within the region. These jobs generated a payroll impact of \$1.2 billion and provided tax benefits estimated at \$84.5 million in state personal income tax revenue and state and local sales tax revenue.

## STATEWIDE ECONOMIC IMPACT

New York State's Independent Sector of higher education is the largest in the country. Private nonprofit colleges and universities in New York enroll 44 percent of the 1.1 million students in postsecondary education in the state and award 60 percent of the bachelor's and graduate degrees earned by these students. Independent colleges and universities are major employers, purchasers of goods and services, and builders. Many of these institutions are the primary employers in the communities in which they reside.<sup>1</sup>

## JOBS

The Independent Sector supported 407,000 jobs across New York in fiscal year 2022-23. That total includes 196,000 direct campus jobs (faculty, staff, and graduate assistant positions). Nearly 90 percent of these jobs are faculty or professional positions. The total also includes on-campus construction and spillover employment. These jobs generated a payroll impact of \$33 billion and provided tax benefits estimated at \$2 billion in state personal income tax revenue and state and local sales tax revenue.
